**Abstract:** A brief one-para abstract should be included (11pt). You should submit the soft copy of the full manuscript at the time of symposium. It would be even better if you can send the completed manuscript by email, before you start for the symposium. Ensure that the text is grammatically correct and properly punctuated. We recommend you request one of your teachers to go through your manuscript before sending us.

## 1. INTRODUCTION (12 PT)

Use A4 size with normal (default) margins for page layout. Use normal line spacing. Fonts used for the entire document should be Times New Roman (or the default CMR fonts in case of tex file) and the main text should be in 12 pt. Text should be justified except the title and author details which should be left-aligned. Length of the manuscript should be between 2 to 5 pages. Language/dictionary used should be English (India) or English (UK). Avoid unnecessary capitalisation of words (or the first letter of words). Unnecessary decorations (boldface, underline, italics, etc.) should also be avoided or kept to minimum.

#### 2. MAJOR SECTIONS

The paper should be divided into numbered sections which can be further divided into subsections. However, Acknowledgement and References will not have any section number.

#### 2.1 Equations

Equations should be numbered sequentially. Place the equation number to the right of the equation. An example would be

$$\frac{d^2x}{dt^2} = -\omega^2 x + \lambda x^3 + b\cos(\omega t). \tag{1}$$

Refer to this equation as Eq. (1).

## 2.2 Figures and Tables

Figures and Tables should also be separately numbered and must have captions. For example:

Figure 1. Phase-space trajectory of simple harmonic oscillator.

Place figure captions directly below each figure. Place table captions just above each table.

## 3. REFERENCING

Include References at the end, numbered with Arabic numerals in square brackets. Reference list should be in 11pt and arranged in the order in which they appear in the text. You can cite journal papers, (see, for example, [1] and [2]), or books (see, for example, [3] and [4]), or papers presented in conferences (see, for example, [5]).

Acknowledgements, if any, can be included just before the References.
